Warrant Case Search Help Guide

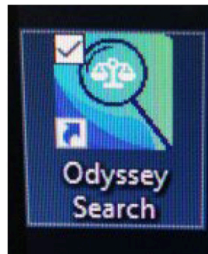
Thank you for your interest in Cook County's *Safety and Justice Challenge* initiative on misdemeanor warrant reduction. The goal of this project is to address dated non-violent misdemeanor active warrants throughout the various judicial districts in Cook County.

The following **Help-Guide** is intended to provide you with steps in researching the status of your warrant related case(s). In addition, we provide general definitions of words that you will find in your search important to the status of a warrant. Please be advised that all Cook County agencies involved in this initiative, including the office of the Clerk of the Circuit Court of Cook County, will not provide any form of legal advice. If you have legal questions, please seek the appropriate supports.

As part of this initiative, litigants/defendants need not be present in court and will not be required to complete any court filings. Staff from the appropriate county offices will examine qualifying cases and proceed with the legal steps to file a motion before a judge to address selected cases.

STEPS - SEARCHING WARRANT CASES

1. Find a Digital Access Terminal (DAT) at your nearest courthouse in the *Office of the Clerk of the Circuit Court*.
2. Double click on the following "Odyssey Search" icon:



3. Enter your 11-digit case number, **OR**
4. Type in your last name and first name (please include a comma in between the last name and first name)

* If you are having trouble finding your case number or case by using your name, feel free to visit the *Clerk of the Circuit Court's* office to retrieve your case number (maintain your case number in a confidential place going forward).

*Also, make sure your case number relates to the warrant in question. You may have active/inactive cases not related to the warrant case.

9. Under “Events and Orders of the Court”, you may find **key terms** that provide additional information about your case:
 - a. **“Motion”** –means your case will be heard on the reported date.
 - b. **“Warrant Quashed”** –means your Warrant case is no longer active as reported date.
 - c. **“Warrant Ordered, Warrant Issued”** –denotes the date the Warrant was ordered.
 - d. **“Warrant Outstanding”** –means the Warrant is active as of that date.
