The new Customer Service Call Center launched by the Clerk of the Circuit Court of Cook County is a great initiative to improve the quality of service provided to court users. With the center staffed by experienced Clerks, users can expect to receive assistance on a wide range of court-related matters from the comfort of their own homes.

Here are some additional points to note about the call center:

- The center operates from Monday - Friday, 8:30 am to 4:30 pm excluding court holidays.
- The centralized number to dial to reach the center is (312) 603-5030.
- Users can expect shorter wait times because each Clerk has been cross-trained on all divisions of law which will result in faster resolution of issues.
- Many questions can be answered and documents can be ordered without having to make an in-person trip to any Cook County courthouse.
- In addition to this comprehensive customer service to court patrons, we also utilize inLingo translation services to assist callers in more than 200 languages.
